LOW GDP QUALIFYING COUNTRIES - 2023

The QRMH9 Committee continues its efforts to recognize high-quality research conducted in countries that are facing financial struggles and where researchers have little access to funds. To support researchers currently working in a low GDP country, QRMH9 offers reduced conference fees¹.

To determine the status of a low GDP country in 2023, QRMH9 uses the World Bank Data for 2021²:

- **African countries**
- **Asian countries** (excluding Brunei Darussalam, Hong Kong SAR, Israel, Japan, Republic of Korea, Kuwait, Macao SAR, Qatar, Singapore, United Arab Emirates)
- **South American and Caribbean countries** (excluding The Bahamas, Bermuda, Cayman Islands, Puerto Rico, Sint Maarten (Dutch), Virgin Islands)
- **South Pacific countries** (excluding Australia, Guam, New Caledonia, New Zealand)
- and the following countries in **wider European area**: Albania, Armenia, Azerbaijan, Belarus, Bosnia and Herzegovina, Bulgaria, Croatia, Czechia, Georgia, Greece, Hungary, Kazakhstan, Kosovo, Latvia, Lithuania, North Macedonia, Moldova, Montenegro, Poland, Portugal, Romania, Russian Federation, Serbia, Slovak Republic, Turkiye and Ukraine.

¹ To qualify for these fees, you must reside and work in a low GDP country (as per your institute and country of employment in your account).

A low-GDP country is determined as a country which has an annual GDP per capita lower than 71% of the GDP of the total European Union (lower than \$ 27 146,21 USD).
